Should any final action, final decision, or vote be required in the opinion of the Board of Directors of the Zavala County Public Facilities Corporation with regard to any matter considered in such closed or executive meeting or session, then the final action decision, or final vote shall be either

(b) at the subsequent public meeting of the Board of Directors of the Zavala County Public Facilities Corporation upon notice thereof; as the Board of Directors of the Zavala County Public Facilities Corporation shall determine.


