

NOTICE OF 2015 TAX YEAR PROPOSED PROPERTY TAX RATE FOR ZAVALA COUNTY

A tax rate of \$0.670000 per \$100 valuation has been proposed by the governing body of ZAVALA COUNTY.

PROPOSED TAX RATE	\$0.670000 per \$100
PRECEDING YEAR'S TAX RATE	\$0.632100 per \$100
EFFECTIVE TAX RATE	\$0.495625 per \$100

The effective tax rate is the total tax rate needed to raise the same amount of property tax revenue for ZAVALA COUNTY from the same properties in both the 2014 tax year and the 2015 tax year.

YOUR TAXES OWED UNDER ANY OF THE ABOVE RATES CAN BE CALCULATED AS FOLLOWS:

$$\text{property tax amount} = (\text{rate}) \times (\text{taxable value of your property}) / 100$$

NOTICE OF 2015 TAX YEAR PROPOSED PROPERTY TAX RATE FOR ZAVALA COUNTY

A tax rate of \$0.670000 per \$100 valuation has been proposed by the governing body of ZAVALA COUNTY. This rate exceeds the lower of the effective or rollback tax rate, and state law requires that two public hearings be held by the governing body before adopting the proposed tax rate.

PROPOSED TAX RATE	\$0.670000 per \$100
PRECEDING YEAR'S TAX RATE	\$0.632100 per \$100
EFFECTIVE TAX RATE	\$0.495625 per \$100
ROLLBACK TAX RATE	\$0.674538 per \$100

The effective tax rate is the total tax rate needed to raise the same amount of property tax revenue for ZAVALA COUNTY from the same properties in both the 2014 tax year and the 2015 tax year.

The rollback tax rate is the highest tax rate that ZAVALA COUNTY may adopt before voters are entitled to petition for an election to limit the rate that may be approved to the rollback rate.

YOUR TAXES OWED UNDER ANY OF THE ABOVE RATES CAN BE CALCULATED AS FOLLOWS:

$$\text{property tax amount} = (\text{rate}) \times (\text{taxable value of your property}) / 100$$
