## ABSENT APPLICANT – APPLICATION FOR MARRIAGE LICENSE INSTRUCTIONS

#### PLEASE READ CAREFULLY

Absent affidavit can be used to apply for a Marriage License when one party is not able to appear in the County Clerk's Office to obtain the marriage license, but **IS ABLE TO PARTICIPATE** in the wedding ceremony.

NO PROXY NECESSARY IF BOTH APPLICANTS WILL BE PRESENT AT WEDDING CEREMONY. One applicant may obtain marriage license in the county clerk's office alone with needed materials. A proxy is a substitute who can act and speak on another's behalf.

- 1. The party who will not be able to appear in the County Clerk's Office must complete and sign this form. All fields 1-15 on the form must be completed by the person signing.
- 2. The other party must appear in the County Clerk's office at least 72 hours, but no more than 30 days prior to the ceremony.

#### WHAT TO BRING INTO THE COUNTY CLERK'S OFFICE:

The fully completed and **notarized affidavit (questions 1-15)**An acceptable form of **identification for both wedding parties** may include the following:

- 1. Valid driver's License \*
- 2. Valid Passport \*
- 3. State issue ID \*
- 4. Military ID \* (waives 72 hr. waiting period)
- 5. Certified Copy/Original birth Certificate NO COPIES
- 6. Offender Card issued by TDCJ \*
- 7. Social Security Cards\*

Copies acceptable for absentees Note: Identification for applicant appearing in person must be original.

The names of both parties will appear on the marriage license **exactly** as they do on the identification that was provided to our office.
